## Ballot Measure “C” (Rent Control) Debate,

May 15<sup>th</sup>

Sonoma League members are invited to attend a debate on measure “C” which is central to the June 6<sup>th</sup> Santa Rosa special election. The debate will be held at Spring Lake Village, 5555 Montgomery drive, in the Montgomery Center Auditorium. It begins at 2:30. The debate is being presented by the Spring Lake Village Local Issues Committee and the LWVSC.

Formally called Santa Rosa Rent Stabilization and Tenant Protection, Measure “C” has generated a great deal of North Bay attention as well as large campaign contributions. Santa Rosa Voters are being asked to support the Santa Rosa Rent Stabilization ordinance which the City Council enacted in August, 2016. The opposition, the California Apartment Association, sponsored a successful signature drive which challenges that City Council decision. They are asking Santa Rosa Voters to vote “No” on the measure.

The Pro rent control debater will be Julie Combs, Santa Rosa City Councilwoman and a major participant in the “Fair and Affordable Santa Rosa” Campaign Organization. The Opposition debater will be Joshua Howard, the senior vice president of the California Apartment Association. The CAA is the primary organization sponsoring this ballot referendum and the opposition campaign, “Citizens for Fair and Equitable Housing.”

Some refer to this June 6<sup>th</sup> ballot measure campaign as a “David and Goliath” race, because the opposition to Measure C had reported that they raised \$390,000, compared to the \$68,000 raised as of the end of March by supporters. These numbers should increase substantially in the next month, according to local political observers.

League members and others are urged not to vote until they hear both sides of this important and complex issues. **Don't mail in your ballot measure too soon!**

The League will be videoing the debate and it will be available through a link on the League's web site. Because of space limitations the public is not invited to hear this debate.

Please note that there is a second measure on the June 6<sup>th</sup> special election ballot. Measure D is a proposed tax on cannabis raised and sold within Santa Rosa.

## President's Message

shall be not more than 60 days nor less than 10 days prior to the date of the annual meeting, nor more than 60 days prior to any other action. When a record date is so fixed, only members on record on that date are entitled to notice, to vote, or to exercise the rights for which the record date was fixed. If no record date is fixed by the Board, the record date shall be 30 days prior to the date of the annual meeting or of such other action.

**Absentee or proxy voting shall not be permitted.**

Section 4. Quorum. Five percent of the membership shall constitute a quorum.

## WE WILL NEED YOUR VOTE ON JUNE 10

As the calendar states, our annual meeting will be held on **June 10** at the Finley Center in Santa Rosa. A preliminary agenda follows which includes timing of our traditional business meeting followed by lunch and our speaker. A full packet of information on issues to be addressed will be posted on our web site no later than two weeks prior to the meeting (May 27). We will have our traditional pot luck lunch and experience testifies to the fact that there will be no lack of food!

Questions arose at the New Member Meeting on April 18 about rules for voting. To satisfy those concerns, I have checked the appropriate section of the By-Laws which appears below:

Article VIII, Section 3. Voting. Each member shall be entitled to one vote only at any meeting of members. The Board may fix, in advance, a record date for the determination of the members entitled to notice of the annual meeting or entitled to exercise any rights in respect of any lawful action. The record date so fixed

My interpretation of this in terms of the annual meeting is that 30 days prior to the annual meeting the treasurer will determine the number of active members. Five percent of that number are necessary at the meeting to conduct business and anyone who joins and pays dues fewer than 10 days prior to the annual meeting is not eligible to vote. I especially urge our new members to come on June 10. It is a great time to get more acquainted with the workings of the League, add your voice to the mix, meet your new Board, get questions answered and mix with other new and experienced members. I'm very much hoping for a large turnout and a stimulating meeting.

### Book Club Reads.

**May 18: Moderated by Carole Sunlight**

*The Oyster War, a true story of a small farm, big politics and the future of wilderness in America,* Summer Brennan, 256 pages, 2015.

Journalist Summer Brennan stumbled onto the Drakes Bay Oyster Company fracas after being hired as a staff writer for the *Point Reyes Light*, a nearby local paper, in 2012. In short order, Brennan, a Point Reyes native who now lives in New York, was embroiled in the controversy, working late nights to discern fact from fiction, and clumsy science from sound policy. *The Oyster War* makes for a fast-paced and dramatic read about a messy situation with no clear-cut “bad guy.”

**June 15: Moderated by Carrie Anabo**

*Just Mercy-a Story of Justice and Redemption,* Bryan Stevenson, 368 pages, 2015.

“Just Mercy” demonstrates, as powerfully as any book on criminal justice that I’ve ever read, the extent to which brutality, unfairness, and racial bias continue to infect criminal law in the United States. You don’t have to read too long to start cheering for this man. Against tremendous odds, Stevenson has worked to free scores of people from wrongful or excessive punishment, arguing five times before the Supreme Court. . . . The book extols not his nobility but that of the cause, and reads like a call to action for all that remains to be done.

On April 28 the League had its first Member Action Meeting at the Santa Rosa Central Library. The topic was housing and homelessness. 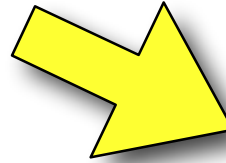
