James Gore is a Sonoma County native who was born in Healdsburg and lived in Cloverdale and Santa Rosa.

Prior to returning to Sonoma County he served as a presidential appointee as Assistant Chief of the U.S. Department of Agriculture's Natural Resources Conservation Service.

While in Washington, D.C., Gore was an active voice regarding Northern California policy issues, gaining feedback, and building partnerships with supervisors and community groups to address concerns at all levels of government.

Currently, he serves as the Co-Leader for the Working Landscapes team of the California Economic Summit. The Summit brings together leaders from throughout the state to take action on California's most pressing issues,

Gore served in the United States Peace Corps as an agricultural and natural resources volunteer in Bolivia, South America.



James Gore holds a Bachelor's Degree in Agribusiness from California Polytechnic State University, San Luis Obispo, and a Master's Degree from George Washington University. He is fluent in Spanish and Italian. James Gore lives in Healdsburg where he and his wife Elizabeth are raising their two-year-old daughter, Opal. On September 21, 2014, the Gore family welcomed the birth of their second child, Jacob.

The issues Supervisor Gore is actively supporting are: jobs and the economy, water, education, public safety, roads, and pensions.

## A MESSAGE FROM OUR CO-PRESIDENT:

A big thank you to all who submitted recommendations for the League of Women Voters of California's (LWVC) 2015-2016 Program. The most frequent suggestion was to support concurrence with the League of Women Voters consensus on the Living Wage.

Two days before the board meeting, we received word that the League of Women Voters of the United States (LWVUS) had decided that state or local Leagues could advocate for a Living Wage under the Meeting Basic Human Needs position statement "People who are unable to work, whose earnings are inadequate or for whom jobs are not available have the right to an income and/or services sufficient to meet their basic needs for food, shelter and access to health care." There seemed to be no need for a state consensus on the living wage.

In the League Update following our board meeting, the LWVUS released a statement clarifying the position. Basically, at the national level "there is no member understanding and agreement as to the definition of a 'living wage', and LWVUS cannot support a federal minimum wage."

According to the Update this means is any state or local League board that wants to take action on the living wage must

... do its due diligence on any proposed legislation that addresses Meeting Basic Human Needs and judge whether there is member understanding and agreement that the proposed legislation meets the criteria quoted above. If it does, then the Board should carefully deliberate and make a decision based upon both the position and the needs of its own community. What fits other communities can only be addressed by the relevant League.

Now it appears that there will be an effort to commit to a living wage study at the LWVC Convention, and our delegates will be able to participate in the discussion there. In the mean time, our League has a position on the living wage issue. You can read about all of our positions on [our website](#).

At our Annual Meeting in May we will decide what our priorities will be for the 2015-2016 local League year. The Board asks that you recommend to the board what our program will be and what we should emphasize in the coming year. You can do so by completing [the form at the members web site](#). If you do not have access to a computer, please call the office. You will be mailed the form with a copy of our current positions. Instructions are on the form. Of course you may move a non-recommended item at the Annual Meeting, but unlike board recommended items, a two thirds vote of those members voting and present are required for consideration.

The city of Santa Rosa is seriously studying the issues of affordable housing and the recommendations raised by its Open Government Task Force. The SRJC Trustees are setting up a study group to consider dividing election District 3,4,5 into separate districts. The study group's first meeting is March 25th.

***Six Amendments: How and Why We Should Change the Constitution*** by Justice John Paul Stevens, 192 pages, 2014.

By the time of his retirement in June 2010, John Paul Stevens had become the second longest serving Justice in the history of the Supreme Court. 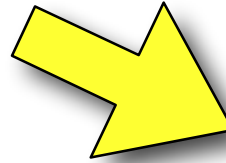
