We hope you will enjoy the many authentic suffrage artifacts on display and books related to the topic, such as, "Mr. President, How Long Must We Wait!" by Tina Cassidy.

The Museum will limit the number of people inside, keeping in line with current COVID safety standards. Masks are required. "Suffrage Headquarters" will remain on view through the summer. So, plan a visit. You will notice cheerful poppies and suffrage banners flying!

May Board Meeting Highlights

At their May 1st Board meeting the members approved several changes to our fiscal policies to ensure we comply with General Accounting Principles. The Board also finalized plans for our participation at the virtual Annual CA League Convention in June. Our delegates are Judie Coleman, Sue Jackson, Donna Roper, and Karen Weeks. Our delegates will be reporting on the Convention at the June 26th Annual Member's Meeting.

The Nominating Committee Chair, Carrie Anabo, reported that we have nominees for most open board positions, but they are still trying to fill a few roles on the Board. There are also some off-Board roles open, including the Bay Area League Representative and the Telephone Tree Coordinator. The Board is exploring ways to raise funds to support Spanish translation for League forums.

Membership renewal information will be finalized once we complete the transition to a new website and management system called Club Express. Santa Rosa Police Actions After the Black Lives Matter Protests in May and June, 2020

In the aftermath of the George Floyd murder in Minneapolis, protests took place in Santa Rosa for several days. The protests were largely peaceful. But there were incidents of vandalism and protester disregard for police efforts to maintain order. As a result, the police engaged in use of force tactics, including tear gas for crowd dispersal and the use of projectiles resulting in injury to some protesters. In the interest of transparency and community engagement, the Santa Rosa City Council held two days of public hearings May 4-5th, 2021. They reviewed and discussed several reports from various entities listed below. There was public comment after each presentation.

- 1) Sonoma County Human Rights Commission,
- 2) The OIR group, an independent consulting firm with expertise in police investigations,
- 3) The Hillard Heintze, LLC: presented an internal review by the police department and city manager,
- 4) The Santa Rosa Office of Community Engagement presented the Community Empowerment Plan Listening Sessions Report,
- 5) Police Reform Update: a report by Rainer Navarro, Chief of Police, and other senior officers presented an update on the police reform actions that have been initiated since June 2020.

The reports and hearings appeared to be an honest and transparent effort to understand what happened and to make improvements. There was detailed analysis and candid discussion of some events where historic policies and methods of police response to peaceful protest, unruly crowds or unlawful behavior now seem inappropriate or are ineffective. The Council members were attentive. They asked pointed questions. The police acknowledged shortcomings and mistakes, and described changes in policy that have been made or are underway. They described some controversial use of force incidents from their perspective. Many heads nodded in agreement when Chief Navarro said "Nobody in the Police Department wants this to happen again."

One LWV member who says he was the organizer of civil rights and antiwar demonstrations in the 1960's added "There are many changes needed in police policy and methods, and some of the protestors have got a lot to learn as well. Nonviolence and demonstration discipline are essential if you are trying to persuade people to support your position." The hearings were an excellent exercise in "Making Democracy Work." We hope this will lead to significant police reform.

Accessing Membership Resources on the Website

Changing your password: After you log in for the first time, you can then choose your own password, **but be sure to write it down**.

Changes to By-laws

Officers:

After several months without a President, at the March 2021 Board meeting an Executive VP position description was approved by the board. The Executive VP will be an assistant to the President and would be a good way for a member to be an understudy for becoming President in the future. The Executive VP and the President will work jointly to keep the League operating smoothly. We are proposing to modify the By-laws to reflect this new position.

Proposed By-Laws Revisions to be ratified by the members in June 2021

Article IV--Officers

Section 1. Enumeration and Election of Officers. The officers of the League shall be a president, one or more vice presidents, a secretary and a treasurer. They shall take office immediately following the annual meeting and shall hold office for one year or until their successors have been elected and qualified.

Section 2. The President. The president shall preside at all meetings of the board of directors. The president shall be an ex-officio member of all committees except the nominating committee and audit committee, if any, and shall have the usual powers of supervision and management as may pertain to the office of president and perform such other duties as may be designated by the board. The president may sign or endorse checks, drafts or notes in the absence, disability, or death of the treasurer. The office of president may be held concurrently by more than one person.

Section 3. The Vice Presidents. There shall be at least one vice president. If there is more than one vice president, one shall be designated as the Executive first vice president. The Executive first vice president shall in the event of the absence, disability, or death of the president possess all the powers and perform all of the duties of that office until the board of directors shall fill the vacancy. Vice presidents shall perform such duties as the nominating committee, the president or the board may designate.

Article VI--Committees

Section 3. Executive Committee.

a) Composition. The executive committee shall be elected at the first board meeting by the newly elected board. It shall include the president, the executive first vice president, and three other officers or directors elected by the board. Three members shall constitute a quorum.

Dues Renewal Date

Our current by-laws call for annual dues which are payable by September 1st of each year. When we move to Club Express this may change to dues being annualized, based upon when the member joined.

- 1. Proposed By-Laws Revisions to be ratified by the members in June 2021
 - a) Article VII--Financial Administration

Section 2. Dues. Annual dues shall be determined by the members at the annual meeting by a majority vote of the local League members present and voting. Such dues shall be payable by each member on a date determined by the Board of Directors. or before September 1 of each year. Board policy shall determine how dues will be assessed and allocated for those joining during the year. When more than one member resides in a household, the dues for each additional member in the household may be reduced by recommendation of the board. Upon the request of a member, the board may reduce the dues for financial hardship. Any member who fails to pay dues within 60 days after they become payable shall be dropped from the membership rolls. Honorary life members shall be exempt from payment of dues.

The Unspeakable Mind: Stories of Trauma and Healing from the Frontlines of PTSD Science, by Shaili Jain, M.D. Pub. Harper Books: May 2020.

The Unspeakable Mind is the definitive guide for a trauma-burdened age. Dr. Jain, a practicing psychiatrist and PTSD scientist at the National Center for PTSD shines a light on the PTSD epidemic affecting today's fractured world.

Post-Traumatic Stress Disorder goes far beyond the horrors of war and is an inescapable part of all our lives. More than six million Americans are suffering with PTSD. Dr. Jain demonstrates the ways this disorder cuts to the heart of life, interfering with one's capacity to love, create, and work—incapacity brought on by a complex interplay between biology, genetics, and environment. Beyond the struggles of individuals, PTSD has a tangible imprint on our cultures and societies around the world.
